On behalf of the infants and toddlers with developmental disabilities in Orange County we are writing to request your generous support of our silent auction and opportunity drawing at our 4th Annual Spring Gala on March 3, 2012 at the Bowers Museum in Santa Ana. Now more than ever our annual event is a critical component of fund raising for the children. This event will be well attended and gives donors exposure to over 1,500 friends and families of ICEC through our website and social networking through Facebook and email.

For more than 30 years we have been providing the highest quality therapy to children in our three Orange County Locations. We are a unique program, offering help to the entire family, counseling, parent education, programs for the siblings, and intensive early intervention programs and therapy to the at risk and disabled babies. Our programs have received significant funding cuts due to the state budget crisis. The children and families not getting the treatment they need or when they do get services it is delayed for months after their diagnoses. Early Intervention works because it is provided early, in those critical first three years of life. The budget cut backs have caused waiting lists and complete elimination of therapy programs for more than 1,700 toddlers in Orange County which is devastating for the families and pushes the educational burden to the public schools. When these children enter kindergarten they require much more expensive intervention - for every \$1 spent on early intervention, \$10 is saved in future social service programs.



*On 8/22/09 William Joseph Daley was brought into this world - it was a blur of lights and people and I remember my doctor looking at me and saying, "I think he has Down syndrome, but we will have to run tests to be sure." The room became very quiet and still in that moment. Four weeks and two surgeries later William finally came home with us. Those four weeks without him at home I read every book I could find and researched information on the internet to find out what I could do to give my son every possible advantage. I stumbled onto the ICEC website and read about the infant program. William had been home for only four days when we took him to his first infant program meeting. We were amazed at how many opportunities there were for him at the infant center. We learned at such an early point about all the things that we could do to help keep him from being delayed. The staff is so warm and inviting and the fact that we didn't feel so alone anymore was huge. We not only found a place for William and us to learn, but a place where other parents were going through the same journey, which was priceless. William is thriving and has made such huge strides in all he does. Each time he goes to class I am amazed by something new he is doing. Watching my beautiful boy grow and learn has been so amazing. ICEC has made those first words I heard while still on the operating table not so daunting. I know that William has a bright future ahead of him and it is programs like ICEC's that make his future so bright.*
